In the event of our being unable to accept the order the full amount deposited with us will be returned without delay.

As soon as the necessary enquiries are completed and the order is accepted arrangements will be made at once to supply the gun or rifle. The second payment will fall due in one month after the gun or rifle is despatched, and subsequent payments on the same date of each succeeding month.
